# 1 — MESSAGE FROM THE PRESIDENT <u>MR DAVID HYNES</u>

On behalf of the Australian Baseball Federation (ABF) I would like to present the 2011/12 Annual Report to our members. The report summarises both the achievements and the challenges over the past year, as well as setting out our plans and initiatives for the future of Australian Baseball.

Having taken over the Presidency of the ABF in February 2012, I must firstly pay tribute to Geoff Pearce for the hard work and commitment he has put in over the past 6 years as President. Geoff remains a director of the ABF board, and I thank him for his continued support and advice.

Deborah Healey stepped down from the board in February 2012, but we welcomed two new directors in late 2012: Rob Sadler and Yasmine Gray. Rob, a barrister, has joined us after many years serving on the board of Baseball Victoria. Yasmine is a marketing and communications specialist who runs her own Public Relations company in Queensland. Yasmine is an enthusiastic newcomer to baseball, but not to the world of sports as she is also a consultant to the Brisbane Broncos.

I would like to recognise and express my appreciation to the other dedicated members of the board, who contribute their expertise as well as many hours of voluntary service to Australian Baseball. Thank you to Ron Finlay, Peter Williams and Evan Stewart. This year the Australian Baseball League built upon its inaugural season success and enjoyed an even more exciting 2011/12 season, with the addition of an All Star Game that was televised live to the world. The 'Alcohol Think Again' Perth Heat repeated as the ABL Champions in season two, with an exciting Championship Series also televised to baseball fans on Fox Sports. The ABL has lifted the public profile of our sport, and it promises to be the driving influence in the continued growth of Australian Baseball. The support of the wider baseball community is critical to the survival of the ABL, and I urge all of our members to get out to some games.

In 2012 there were successful National Championships held for Little League, Under 14's, 16's, 18's, 23's, Women and, for the first time ever, a National Championships was held for Under 15 Girls. It was terrific to see so many players from all over the country come together for these exciting tournaments.

In the 2011/12 year Baseball Australia sent teams to the IBAF World Cup in Panama, the AA World Championships in Mexico (Under 17), the Cal Ripken World Series in the USA, the AAA Oceania Qualifier in Guam, as well as the Asia region Little League World Series qualifier in Taiwan. We should be very proud of the way all of these players represented their country, and excited to know in 2013 the Australia Region Little League Champion team will have direct entry to the Little League World Series in Williamsport, Pennsylvania, USA.

We will continue working with sporting organisations at all levels to ensure the program provides maximum value to sports and supports the transition of program participants into local clubs.

Linked to the London Olympic and Paralympic Games, the Prime Minister's Olympic and Paralympic Challenges will encourage and inspire children to participate in sport and to get active, have fun and earn rewards. This initiative, as well as participation funding programs delivered by NSOs, continues the Australian Government's commitment to ensuring more people can access sport and all the benefits it provides.

The support received from the Australian Government for Australian sport is essential and plays an integral role in connecting our young sporting participants with their dreams of podium success in the future.

This is an exciting and challenging time for Australian sport. The Australian Sports Commission looks forward to working with sporting organisations, state and territory institutes and academies of sport, and state and territory departments of sport and recreation, to promote access to, and participation in, sport across the community, and supporting Australia's continued sporting success.



# 3 — MESSAGE FROM THE CEO MR BRETT PICKETT

# It is with much pleasure that I present the 2011/2012 Australian Baseball Federation (ABF) Annual Report.

The 2011/2012 Year represented my first full year as CEO of the ABF, and I am delighted to be able to reflect upon and report on the many successes that we have achieved as a sport over the past twelve months and of course touch upon the challenges that we face moving forward.

Perhaps the most pleasing aspect of the year, and what may be classified as the best indicator for the health of our game, has been the continual increase of our Full Active Membership base. A further 8% increase on the previous year, has seen our membership base increase to over 40,000 members around the country. At the current rate of growth, we are well on track to achieve our current strategic objective of 50,000 members (by end 2014) and are well positioned to return baseball to the halcyon days of our sport in the mid 1990's when annual membership was 50,000+ and we had a thriving National League.

- Of course, Full Active Membership numbers are not the only metric of success, and as a sport we have performed admirably in a number of other areas of our business, including:
- Our National Men's team equalled their best ever World Cup result, securing 5th place at the 2011 World Cup, narrowly missing out on a medal;
- A further 8 young Aussies joined the ranks of professional baseball, joining the 300+ that have gone before them;
- Women's baseball continues to thrive, with the establishment of the first ever National U15

Girls Championships;

- The ABL enjoyed its second year of growth;
- Aussie T-Ball, our games highly regarded national junior point entry program continued to grow, with over 180 clubs and over 100 schools now delivering the program;
- Australia gaining direct entry into the Little League World Series for 2013 and beyond.

The year also saw a change to the ABF President, with Geoff Pearce deciding to step down as President of the ABF Board, and David Hynes being appointed as his successor. I would like to take this opportunity to thank Geoff for his time, expertise and endless commitment over the past six years as he oversaw a remarkable period for Australian Baseball, perhaps highlighted by the re-establishment of the allimportant Australian Baseball League. Geoff remains on the ABF Board as a Director, so fortunately his vast experience, skill set and enthusiasm is still available to the sport.

Deborah Healey also resigned as a Board member of the ABF after ten years, and I pay tribute to the dedication of Deborah during this time and thank her for the positive impact her knowledge and guidance has made on Baseball in Australia.

I naturally look forward to working with David in his role as President of the ABF Board as we work towards increased growth of our great game.

As mentioned above, the Australian Baseball League (ABL) also enjoyed its second year, with the Perth Heat winning the ABL Championships series for the second consecutive year, maintaining their position as Claxton Shield Champions.

The ABL continues to grow and importantly generate a positive impact on the entire Australian Baseball community. 2nd year highlights included the introduction of the ABL All-Star game (played in front of a sell out crowd and a record international TV audience), increased crowds around the League and an improved commercial and media profile. I'd like to congratulate ABL CEO Peter Wermuth and his management team for another positive season and we of course look forward to working with the ABL towards further success for many years to come.

2012 also saw the establishment of the inaugural Australian Baseball Summit. The Summit, now to be a permanent fixture on the annual calendar, saw representatives from all Australian Baseball stakeholders gather in Sydney for 4 days of meetings, workshops and presentations, all designed with the express purpose of collectively growing the sport in Australia. I congratulate all who attended for the professionalism and spirit in which they participated, for the ideas that were generated and for the energy that was expended, all for the greater good of baseball.

At no other time in history, has Australian sport faced so many challenges. The sheer volume of options for people to choose from; the financial pressures faced by most Australian families; the changing dynamics of the way Generation Y wants to engage in recreation; are just a few of the challenges we face as we seek to grow our great sport. The ABF, and its network of stakeholders are actively pursuing strategies to counteract these challenges and continue to grow the game we all love so much. As always there is much work to be done, but I strongly believe we are on the right path. I look forward to the year ahead.

# **Principal Activities**

The general activities of ABF are set out throughout this Annual Report and there were no significant changes from the principal mission "to provide national leadership and a national framework for harnessing the energies of the many baseball people and organisation throughout Australia with the aim of building the business of baseball for the benefit of all".

## **Review of Operations**

The Australian Baseball Federation (ABF) is the peak body for the sport of baseball in Australia. It is recognised by the International Baseball Federation (IBAF), the Australian Sports Commission, the Australian Olympic Committee, Major League Baseball and other professional leagues around the world.

The ABF's main function is to conduct, encourage, promote, standardise, control and administer all forms of the sport throughout Australia. As part of its operations the ABF also conducts the annual Major League Baseball Australian Academy Program (M.L.B.A.A.P.), in conjunction with Major League Baseball (MLB), which is the benchmark player development program for the sport. The ABF is also a partner in a joint venture with MLB to operate the professional Australian Baseball League (ABL).

# NOTE 1 -STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

#### **Reporting Status**

The directors have determined that the company is not a reporting entity. As a result, the financial report is a special purpose financial report prepared to satisfy the financial report preparation requirements of the Corporations Act 2001.

The Australian Baseball Federation Inc. is an incorporated society, registered in South Australia. The association's principal activity is to manage, devlop and promote baseball in Australia.

#### **Basis of Preparation**

The report has been prepared in accordance with the requirements of the Corporations Act 2001, and the following applicable Australian Accounting Standards:

- + AASB 101: Presentation of Financial Statements
- + AASB 107: Cash Flow Statements
- AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1031: Materiality
- AASB 1048: Interpretation and Application of Standards

No other Accounting Standard, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have mandatory application. The company has however applied the measurement and recognition criteria of all accounting standards.

#### **Reporting Basis and Conventions**

The financial report is presented in Australian dollars.

The financial report has been prepared on an accruals basis and is based on historical costs modified by the revaluation of selected noncurrent assets, financial assets and financial liabilities for which the fair value basis of accounting has been applied. The directors evaluate estimates and judgements incorporated into the financial report based on historical knowledge and best available current information. Estimates assume a reasonable expectation of future events and are based on current trends and economic data, obtained both externally and within the company. There were no key adjustments during the year which required accounting estimates or judgements.

The following is a summary of the material accounting policies adopted by the company in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

- The charge for current income tax expense is based on the profit/loss for the year adjusted for any non-assessable or disallowed items. It is calculated using the tax rates that have been enacted or are substantially enacted by the balance sheet date.
- Deferred tax is accounted for using the balance sheet liability method in respect of temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the financial statements. No deferred income tax will be recognised from the initial recognition of an asset or liability, excluding a business combination, where there is no effect on accounting or taxable profit or loss.
- Deferred tax is calculated at the tax rates that are expected to apply to the period when the asset is realised or liability is settled. Deferred tax is credited in the income statement except where it relates to items that may be credited directly to equity, in which case the deferred tax is adjusted directly against equity.
- Deferred income tax assets are recognised to the extent that it is probable that future tax profits will be available against which deductible temporary differences can be utilised. Future income tax benefits in relation to tax losses are not brought to account unless there is virtual certainty of realisation of the benefit.

# (b) Property, Plant, and Equipment

Property, plant and equipment are brought to account at cost or at independent or directors' valuation, less, where applicable, any accumulated depreciation or amortisation. The carrying amount of property, plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows which will be received from the assets employment and subsequent disposal.

The depreciable amount of all fixed assets including capitalised lease assets, but excluding freehold land, are depreciated over their useful lives using the diminishing method commencing from the time the asset is held ready for use. Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements. Depreciation rates and methods are reviewed annually and, if necessary, adjustments are made.

The depreciation rates used for each class of depreciable asset are:

The gain or loss on disposal of all fixed assets, including re-valued assets, is determined as the difference between the carrying amount of the asset at the time of disposal and the proceeds of disposal, and is included in operating profit before income tax of the economic entity in the year of disposal. Any realised revaluation increment relating to the disposed asset, which is included in the asset revaluation reserve, is transferred to retained earnings at the time of disposal.

# (c) Intangibles

# Licences, Patents and trademarks

Licences, patents and trademarks are recognised at cost of acquisition. All intellectual property has a finite life and is carried at cost less any accumulated amortisation and any impairment losses.

# Research and Development

Expenditure during the research phase of a project is recognised as an expense when incurred. Development costs are capitalised only when technical feasibility studies identify that the project will deliver future economic benefits and these benefits can be measured reliably.

Development costs have a finite life and are amortised on a systematic basis matched to the future economic benefits over the useful life of the project.

# (d) Impairment of Assets

At each reporting date, the company reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

# (e) Payables

A liability is recorded for trade creditors and other accounts payable with respect to goods and services received prior to balance date, whether invoiced to the company or not. Trade creditors and other accounts payable are normally settled within 30 days.

# (f) Employee Benefits

Provision is made for the company's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits expected to be settled within one year together with entitlements arising from wages and salaries and annual leave which will be settled after one year, have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. Other employee benefits payable later than one year have been measured at the present value of the estimated future cash outflows to be made for those benefits.

Contributions are made by the company to employee superannuation funds and are charged as expenses when incurred.

These notes should be read in conjunction with the financial reports.

# (g) Provisions

Provisions are recognised when the company has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

# (h) Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within short-term borrowings in current liabilities on the balance sheet.

For the purposes of the statement of cash flows, cash includes cash on hand and in banks and investments in money market instruments, net of any outstanding bank overdrafts.

# (i) Trade Debtors

Sales made on credit are included in "Trade Debtors" and are recorded at the balance due, less a provision for doubtful debts for an amount estimated to be uncollectible. Trade debtors are due within 30 days from the end of the month.

# (j) Revenue

Income is recorded on an accruals basis as the goods are delivered or the service provided. Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Government grants are only recognised as revenue when they are received and there is reasonable assurance that the company will or has complied with the conditions attaching to them. Grants are recognised as income over the periods necessary to match them with the related costs which they are intended to compensate.

All revenue is stated net of the amount of goods and services tax (GST).

# (k) Financial Instruments Recognition

Financial instruments are initially measured at cost on trade date, which includes transaction costs, when the related contractual rights or obligations exist. Subsequent to initial recognition these instruments are measured as set out below.

### Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market and are stated at amortised cost using the effective interest rate method.

# Financial liabilities

Non-derivative financial liabilities are recognised at amortised cost, comprising original debt less principal payments and amortisation.

# Fair value

Fair value is determined based on current bid prices for all quoted investments. Valuation techniques are applied to determine the fair value for all unlisted securities, including recent arm's length transactions, reference to similar instruments and option pricing models.

#### Impairment

At each reporting date, the group assess whether there is objective evidence that a financial instrument has been impaired. In the case of available-for-sale financial instruments, a prolonged decline in the value of the instrument is considered to determine whether an impairment has arisen. Impairment losses are recognised in the income statement.

These notes should be read in conjunction with the financial reports.

#### (l) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). In these circumstances the GST is recognised as part of the cost of acquisitions of the asset or as part of an item of the expense. Receivables and payables are stated with the amount of GST included.

The net amount of GST receivable/payable to the ATO is included as a current asset/liability in the balance sheet.

Cash flows are included in the statement of cash flows on a gross basis. The GST components of cash flows arising from investing and financing activities, which are recoverable from, or payable to the ATO, are classified as operating cash flows.

Comparative figures have also been changed where classifications of income and expenditure items have been altered from the prior year as a result of a review by the directors. The new classifications have been altered to reflect a more accurate view of the company's operations.

### 2012 Umpire Development

# Recruitment, Development and Training

There were a number of seminars aimed at the basic training of umpires conducted around the country by state umpire bodies.

A current avenue for Umpire Development has been the increasing success of Little League. This was exhibited during the National Little League Championships in 2011 and 2012 where umpires from all states participated.

There are a number of umpires who are dedicated to Little League officiating thus showing a need for a program specific to Little League. A specific Little League program has been designed and is included in the ABF Umpire Development Program.

There have been Little League Umpire Coordinators appointed in WA, SA, VIC, NSW and QLD with an intention to explore the possibilities to extend this to ACT and NT in 2012/13.. These coordinators report back to the ABF Technical Officials Manager via their State Director of Umpiring.

The incentive for umpires to officiate at National Championships where all states/territories can nominate umpires to attend all National Championships is proving successful providing umpires further goals in their career paths.

## Major League Baseball Academy Program

The ongoing inclusion of the Umpire Development Program in the Academy Program is proving to be most beneficial in training of umpires who have been identified as having the potential and aspiration to officiate at higher levels.

The 2012 program was of a standard that catered for umpires to hone their skills under supervision from ABF Accredited Instructors though daily assessment.

During the program the umpires have the opportunity to work high standard games and gain the experience of calling excellent pitching.

Steve Legge (V), Neil Medlin (WA), Rod Moon (V), Brett Fewson (ACT), Dan Beehan (ACT) and Craig Durdin (V) attended the 2012 MLBAAP.

Over the nine years of the program eighty-three umpires have attended.

Attendees include three umpires who umpired professional baseball, six have umpired internationally, and approximately sixty percent have officiated at national championships.

### **Overseas Umpires**

There are three umpires umpiring in professional baseball in the US, Brett Robson, Jon Byrne, Travis Hatch.

Brett and Jon are in AAA while Travis officiated in AA.

### **International Appointments**

The training of scorers under a National Training Scheme is growing and proving successful. Another train the trainer workshop was conducted thus increasing the number of trained personnel throughout Australia.

Similar to the opportunity provided to umpires scorers have been provided with pathways and goals to attend National Championships.

We are exploring through IBAF the possibility of extending the career path internationally for scorers as there is for umpires.

## 8 — PLAYER AND COACH DEVELOPMENT

Player and Coach Development has been greatly assisted by the continued part-time employment of Bill O'Sullivan as Player Development Coordinator, and the full-time addition of a new Coach Development Coordinator, Drew Samuelson; an experienced baseball administrator from Seattle in the US. Progress in several key areas has accelerated markedly since their commencement.

### The Major League Baseball Australian Academy Program

Another extremely successful Major League Baseball Australian Academy Program (MLBAAP) was conducted at the Palm Meadows baseball complex on the Gold Coast from June 23 to August 4, 2012.

Initially intended to commence two weeks later, the program was brought forward due to the substantial interest from professional clubs in this year's crop of players, made more urgent by the July 5 implementation of an international cap on signing bonuses. Over the first two weeks, unfortunately, the camp experienced possibly the most weather disruptions of any to date. Nevertheless, with a tremendous coaching staff, excellent administration and a fine collection of athletes, a very enjoyable and productive camp eventuated. The program seems to get a little better each year, substantially because the core staff members have the routine down pat, and the inclusion of other quality coaches unfailingly adds an extra dimension to proceedings. Now in its twelfth year, this program has for most of that time been staffed by the same individuals, and there is not much to be added to what has been said of them in previous years.

However, the energy and freshness added by the inclusion of new faces is very noticeable, and on this note, mention should be made of Jason Pospishil's efforts as the Infield Coordinator, and Greg Jelks as a Hitting Coach. The additional presence of Craig Shipley also had a huge impact, perhaps even more on the coaches than on the players. There is no substitute for the knowledge that Craig's enormous volume of experience, at the highest levels of baseball, can bring.

Considerable preparation had again been done by administrative personnel, very competently led by Bill O'Sullivan, to tidy up any loose ends prior to camp, and to ensure that everything was ready from Day One. Bill worked diligently to bring about improvements to the quality of the playing surface, and to the facility generally, and great progress was made.

The hitting cages were fitted with new nets and artificial turf, the tee netting was extended and upgraded, the mounds on both fields and in bullpen area upgraded and re-shaped, home plate area on the main field was raised and levelled, the infield dirt on both fields was ploughed up and re-levelled (eliminating lips on edges), the old grass was ripped up, and the entire infield and outfield was weeded, planted, and fertilised, the underground watering system was re-established, including new pump from nearby lake storage and 24 hour access, and both fields were top-dressed.

As with previous years, the MLBAAP placed a heavy emphasis on three components:

- On-field technical, tactical, and physical development;
- + Sports science and sports medicine; and
- Off-field education and character development

With the maintenance of proper focus on all three being a requirement for athletes to maintain their scholarship, it was particularly pleasing that all athletes adhered to the program and successfully worked on all aspects of their development as baseball players.

The appreciation and gratitude of the ABF is extended to the major sponsors of the program – MLB and the ASC. Without the highly valued support of both of these organisations, the program could not act to the capacity it does and our ability to produce the athletes that we do would be very limited

### **HP Coach Development**

While we have had Phil Dale as National Pitching Coordinator for some time, this has been the first year that we have had a National Hitting Coordinator, with Glenn Williams taking on this important role. Hitting and pitching are obviously two critical aspects of the game, and certainly any efforts to improve our performance and international competitiveness must include serious efforts in these areas. With Phil and Glenn at the helm, we are well underway to lifting the overall standard of play within Australia and abroad.

The National Coordinators have been charged with the task of formulating and implementing an effective long-term process for the improvement of our standard in these disciplines. As neither has the luxury of being able to devote himself to the task on a full-time basis, a great deal remains to be done. It is critical that development in these areas is led by individuals with the long term perspective that can only come from long years of emersion in the game, and simultaneously possess a thorough understanding of the skill acquisition process. October of 2011 saw two fortunate coaches, Shane Watson and Kevin Fenn, spend three weeks as guest coaches in the Instructional League program of a professional club. Both Kevin and Shayne reported an outstanding experience, and provided excellent feedback in the form of written reports which clearly outlined the daily regimen and the knowledge they had acquired.

This opportunity is provided each year as part of the MLB Coach Exchange program, and is an extremely valuable tool in many ways. Not only do those attending get to experience the daily grind on professional baseball and learn a lot about the physical and technical development of players at an advanced level, they emerge with a greatly enhanced perspective on the players they will be working with when back in Australia.

## **College Information Program**

With new MLB regulations coming into force in early July 2012 that are likely to reduce the availability of professional opportunities for our players, Baseball Australia has been working to assist those looking to play baseball in US colleges.

American intercollegiate baseball ("college ball") provides an ideal non-professional development pathway for Australian amateurs. They can play up to 90 games per year, receive intensive baseball instruction on a daily basis, earn a subsidized university degree, gain scout and media exposure, and become eligible to be drafted. The ABF's American intercollegiate athletics information program focuses on:

- Educating Australian amateur players, and their parents, on the issues surrounding US college athletic scholarship opportunities: admission processes; academic standards; athletics standards; costs (tuition, books, and living); benefits; and risks.
- Providing resources to assist with the process of college placement.
- Establishing and promoting credible relationships with compatible American coaches who are willing to properly develop and advance Australian amateur talent.
- A player development website, now in its rudimentary stages, to better facilitate talent identification and acquisition of talent by both collegiate and professional organizations.

In the upcoming year, we will be conducting educational seminars at all three National Youth Championships, in State Academies, and the MLBAAP. Ultimately, HPMs will conduct seminars at their respective states. Also planned is a player development database that tracks traditional performance measures, HPM commentary, and performance video in order to provide an objective assessment of Australian amateurs and effectively operate as an 'eCatalog' for talent evaluators.

## State Academies Program (SAP)

The State Academies Program has again performed very well. The High Performance Managers (HPMs) in each state have a complex and difficult role, and are to be congratulated on the great results being achieved. They are charged with implementing a development program for their states emerging elite players, and in doing so cater to the specific constraints imposed by the particular advantages and challenges of the local geography, weather, population and its distribution, facilities and available human resources.

The Academies adhere to a nationally devised curriculum, designed to achieve national objectives. They also aim to see that underpinning programs are geared to produce a consistent and continuing stream of well-prepared players to feed in at the bottom end. The other key role for the SAP is the development of coaches, particularly through overall management of the state teams program in each state. This year has seen an expansion of this function, with all states either continuing or increasing their efforts in this area.

## National Coaches Accreditation Scheme (NCAS)

The new NCAS has steadily gained momentum. Two hundred and eighty-two new accreditations have been registered this year, with a good proportional distribution of levels. At the time of writing, we have 1455 coaches accredited nationally which, while the quality of those coaches is more important than the raw numbers, remains something that needs to be improved, as it represents less than one in twenty of our membership.

Some amendments to the scheme's resources have taken place, with particular emphasis on making the various aspects of assessments easier to conduct, while at the same time ensuring the strict adherence to standards. All manuals have been fully illustrated for some time, and have undergone, or are currently undergoing, cosmetic enhancement, with upgraded photographs and graphic layout by external providers. The coming year will see the online version of the manuals linked to video which will provide even geographically remote coaches with the means to see clear demonstrations of each of the activities included in the scheme.

Despite a few hiccups relating to the ASC's Sports Accreditation Online (SAO) database, the transition from the old scheme to the new has been finalised. In September, all currently accredited coaches on SAO had their level of accreditation moved up one numerical value, with their "old scheme" expiry date of retained. These coaches received a new accreditation card (now produced in-house) to mark the occasion and reinforce the change in emphasis represented by the new scheme.

### 2012-13

The big project for the upcoming year is the Pathway Review. Two events in particular make such an undertaking the prudent and timely: the International Baseball Federation (IBAF) recently changed the ages for the international events it will conduct, and Australia has been granted to the Little League World Series in the US.

Little League has been a major contributor to our participation increase over recent years. It seems that the opportunity for a local community to assemble and develop a team which can ultimately be crowned national champions has great appeal, and the addition of the amazing opportunity to continue further and compete in the US against teams from all over the world can only add to that allure. Not many sports can offer such a chance.

The case in point, however, is that Little League conducts competitions at other age groups as well, roughly equivalent to what would be Under 11, Under 15, and Under 17 for us. One of the many questions to be addressed by the Pathway Review is whether the sport would be better off transitioning to the community/charter format employed by Little League for these age groups as well, rather than the current structures, with its hierarchy of selections culminating the naming of a state all star team to compete in a National Youth Championship.

These issues are not the sole reason for the Pathway Review, but do provide the catalyst for doing it now, rather than later. As stated in the Review's Terms of Reference, the goal is to design a unified whole of sport pathway that provides maximum opportunity for the ignition of interest in the game among participants of all types and thus greatly increases their numbers and continuing involvement, the overall level of interest in baseball in Australia, and the quality of our play. The process will involve the collection of feedback from the membership using online surveys, as well as targeted interviews with identified individuals and focus groups. It is to be hoped that all who care about baseball in Australia will take the opportunity to contribute to the discussion.

This year will also see the availability of an expanding collection of online coaching resources, in both video format and as downloadable manuals. These have taken far longer to develop than had been hoped, but promise to make up to date information, drills and technical instruction available to all coaches and players, and not just those privileged enough to be involved in our high performance programs.

## <u>9 — 2011/2012 PARTICIPATION</u>

The 2011/2012 season saw significant growth for baseball in Australia with over 40,000 Full Active Members involved in the game. This represents an overall increase of 8% on 2010/2011, with our junior entry point programs memberships up 13.5%. Baseball was one of only four sports nationally to receive a rating of "High" for our Participation efforts from the Australian Sports Commission (ASC). We remain well on track to achieve the National Participation Plan goal of a Full Active Member base of 50,000 by the end of the 2014 season

This growth is reflective of the hard work put in by our State Organisations, Regional Associations and Local Clubs towards the recruitment and retention of players, coaches, officials and volunteers. The confirmation of Australia's automatic entry to the Little League World Series in Williamsport Pennsylvania from 2013 further highlights the opportunities that lay ahead for young baseball players and the overall growth of the sport.

It is also thanks to the relationships with Major League Baseball (MLB) and the Australian Baseball League (ABL) that baseball participation continues to grow in Australia. The commitment of MLB to the success of Aussie T-Ball and providing the dream for young baseball players across the country is outstanding and appreciated. The ABL continues to support the ABF and State Organisations in our recruitment and promotion efforts creating a synergy from grass roots participation through to a domestic professional league. Great initiatives for the 2012/13 ABL season include the ConocoPhillips Australia ABL Kids Day At The Ballpark which will see every child aged 14 and under given the chance to experience ABL baseball for free.

### **State Participation Grants**

In 2011/12 the ABF initiated the State Participation Grants program that saw \$45,000 awarded to State Organisations to help with Participation efforts. Participation efforts are classified as any program, action or initiative that can be measured to have a direct positive impact on the Full Active Membership of the respective region. The State Participation Grants are a direct result of the ABF's increased commercial focus and effective utilisation of our sports various commercial assets to raise nongovernment revenue. Based on the success of these commercial activities it is hoped that in future years this funding can continue to grow.









### Aussie T-Ball

The on-going success of the Australian Government's Active After-school Communities program has further seen Aussie T-Ball delivered to thousands of primary aged children Australia wide. This program remains a priority for our growth in the junior age groups through relationship building between schools and baseball clubs.

## Tee-Ball Association of Western Australia

2012 also saw the formalisation of the partnership between the Tee-Ball Association of WA (TBAWA), Baseball WA (BWA) and the Australian Baseball Federation (ABF).

TBAWA have run outstanding Tee-Ball programs throughout Western Australia for over thirty years and have been instrumental in the development of a number of Australian baseball stars. This partnership ensures a strong foundation for the future success of Tee-Ball and baseball in Western Australia.

# Australian Baseball Women's Steering Committee (ABWSC)

The Australian Baseball Women's Steering Committee remains committed to the strengthening of women's baseball around Australia. The inaugural Under 15 Women's National Championships, held in conjunction with the National Women's Championships, were a resounding success and indicative of the opportunity to develop baseball as a sport of choice for girls and women.

For the 2012/2013 season, the ABWSC is focussed not only on expanding competition and playing opportunities, but also on developing women's mentor and leadership positions. This will include the creation of Targeted Women's Coaching and Official Programs. After another successful Women's World Cup campaign in 2012, 2013 competition opportunities will include the inaugural Women's ABL All-Star Game to be played between NSW and an Australian All-Star team and an Australian 18 and Under Team playing in the Phoenix cup in Hong Kong.

## 10 — MARKETING, COMMUNICATIONS AND MEMBERSHIP

Baseball embraced the use of social media as a tool to further engage the Australian Baseball Community and converse with our international supporters on a daily basis. Dedicated Team Australia Facebook and Twitter accounts proved successful allowing constant game updates without impacting on the experience of other general baseball followers. Instead of duplicating to new social media platforms such as Instagram, we chose to focus on bettering our existing platforms, which proved a successful option with substantial growth in followers across all mediums.

New website templates for the Team Australia and National Youth Championships sitelets created an interactive and visual experience that was easier for the public to navigate and enjoy. Used as a test for our website functionality, it was well received by the public with hits up over 150 percent for these sites during tournament and international event times.

A stronger integration of marketing and communications initiatives with the Australian Baseball League (ABL) and Major League Baseball International streamlined our resource use and refined our communication channels. This assisted in media traction and clear communication to our combined fan base and stakeholders.

Leveraging of resources with the ABL allowed the live streaming of the National Little League Championships which was very well received by the grassroots community, ABL fans, and also major partners and sponsors of the sport.

The promotion of Team Australia on home soil was ramped up in another cross-promotion initiative with the ABL. The 2011 ABL All-Star Game was televised live in Australia on Fox Sports, and international coverage on ESPN Star in Asia and the MLB Network in the US. This created an otherwise unfeasible platform for our national team on home soil and built strong public and media interest which will be leveraged into upcoming international events.

The Baseball Australia merchandise range commenced with a selection of Majestic and New Era national team and A-Roo apparel and caps for the public which quickly sold out with hot consumer demand. Our existing partners Majestic and New Era have an established brand profile in Australia beyond the baseball community and the expansion of the merchandise range will use this connection to further our consumer reach.

### **Bellevue IT And SportingPulse**

In July 2012, Australia's largest community sporting network, SportingPulse officially announced their acquisition of Bellevue IT (BvIT); the service provider for Australian Baseball's CRM database, website and competition management system since 2003.

SportingPulse provides some of Australia's largest sporting organisations with the tools to manage their organisations and competitions, publish websites, and communicate with participants at a community level. The company's acquisition of BvIT meant that existing BvIT clients including Baseball Australia were transitioned to the Sporting Pulse servicing network whilst remaining with the BvIT MyClub technology. The Australian Baseball Federation are reviewing our service provider options to ensure that the upgrade to our technology is the best option for our members.

### Australian Baseball Summit

The inaugural Australian Baseball Summit was held in Rushcutters Bay, Sydney from 22 – 25 February. Hot off the back of the ABL Championship Series, the Summit brought together stakeholders from every level of Australian Baseball. Over fifty delegates attended the four day convention, with delegates from the Australian Baseball Federation, Australian Baseball League and its Teams, State and Territory Associations, Baseball Operations Committee, Developments Officers, National Technical Committee ABF and ABL Board, ABF Council and the Australian Sports Commission.

The Summit provided a setting for stakeholders at all levels to come together, review the successes and struggles of 2011 and plan for the coming year. The inaugural event was a success and planning is underway for the 2013 Summit to make it an annual event.

## 11 — ABL 2011/12 SEASON REPORT SEASON REPORT

In just its second year, the Australian Baseball League made tremendous strides, both on and off the field.

On the field, we saw the addition of premier events and achieved some truly outstanding results that have garnered the league and baseball in Australia genuine international attention, including broadcasting the newly created ABL All-Star Game and the ABL Championship Series (ABLCS) – both events played in front of sold out crowds and broadcast into over 50 countries and 500 million homes worldwide.

We saw an increase in both the numbers, and talent levels of our international players – with MLB (Major League Baseball) clubs and NPB (Nippon Professional Baseball) both supporting the league in spades. The ABL also saw its first two international players ascend to the Major League level in the 2012 MLB season, with Didi Gregorious (Canberra 2010-11) and Brandon Barnes (Sydney 2011-12) both getting their first taste of the "show".

Our home-grown stars achieved tremendous success as well; highlighted by the return of star players like Brad Harman who set a new season high in Home Runs (15); Brad Thomas, who was dominant for Sydney on the mound; and Travis Blackley, whose late season heroics saw him catapulted back into the big leagues and playing a key role in the 2012 Oakland Athletics dream run to the MLB playoffs. In total, 7 of Australia's 31 alltime major leaguers played in the ABL this season, with a further 6 international MLB players joining them in the fray. The ABL also took part in the 2011 Asia Series in November 2011. Hosted in Taichung, Taiwan -Perth Heat represented the ABL as reigning 2010-11 Champions and took on some of the best players in the world in the likes of champion teams from the Korean Baseball Organisation (KBO), Chinese Professional Baseball League (CPBL) and NPB.

Possibly the greatest on-field highlight was the thrilling ABLCS, where run-away league leader Perth Heat were taken to the absolute limits by a resurgent Melbourne Aces outfit that took the series to the 13th inning in both games two and three before the Heat were finally crowned backto-back ABL Champions in front of a raucous home town crowd.

Off the field the highlights were much the same with a number of landmark deals and enormous growth in several markets. The League office move in August 2011 from the Gold Coast to Sydney spoke volumes to a renewed focus on both the corporate and commercial success of the league. Overall the ABL and its six teams raised revenues by over 50% in year two, driven primarily by a 71% growth in sponsorship and corporate sales, a 40% growth in Concession income and a 31% growth in ticket revenues.



The increased profile of the ABL and the consolidation of the league's place in the Australian sporting landscape have paved the way to the start of a revitalization for the sport in this country. While it's impossible to measure all the influences, just some of the highlights were:

- 1,987 ABL media stories during the 2011-12 season, reaching a cumulative audience/circulation of 238,404,737 people
- Over \$26 million worth of free advertising for the sport secured through ABL PR efforts in 2011-12
- The ABL website generated 4,390,319 unique page views during the 2011-12 season
- Australia's first weekly radio show devoted to baseball was created in collaboration with ABC Grandstand, and Melbourne's biggest sports radio station SEN carried Aces games
- All teams streamed games live via the internet on their respective sites; one club, Brisbane, has their own free to air TV program ("The Rookie"), and one, Perth, their own online show
- The ABL expanded its television audience significantly from the inaugural season, with the ABLCS and the newly created ABL ASG broadcast to over 50 countries and 500 million homes
- Partnerships have been forged with ESPN Star, Australia Network, MLB Network, and Sky Sport New Zealand to showcase Australian baseball talent to the world
- Upgraded venues & amenities, with better playing surfaces, fan-friendly field layout, and new corporate boxes, new on-field seats and better food vendors in all ABL markets
- + Increased game schedule to 45 games (from 40) and expanded playoffs
- Increased international participation to 13 countries (up from eight), seven MLB clubs (up from four), four Nippon Professional Baseball clubs (up from two), and 13 foreign players signed directly by the ABL
- Increased promotional initiatives and community engagement saw the ABL out in the community more than ever before





### **Baseball Operations**

Over the 2011-12 ABL regular season, 135 games and over 1,000 innings of ABL action were played throughout the course of 12 weeks. Stars emerged amongst all six teams and new records and league firsts were achieved. Fittingly, the season began with Perth setting a record for the longest win streak when the Heat won their first 11 games.

While Perth's streak to start the season put them as a clear leader at the end of the regular season; the other 5 teams enjoyed unprecedented parity, with all five being tied for 2nd place going into the final day of the regular season – which ultimately saw Melbourne finish just one game ahead of a 4-way tie for 3rd place.

Offensively, Canberra's first baseman Brian Burgamy not only led the league in hits (67), runs (41) and batting average—his .409 AVG set a new ABL record, Elliot Biddle of the Melbourne Aces led the league with his record breaking 42 RBIs in a season while his teammate Brad Harman set the ABL record for home runs in a season (15). Sydney's David Kandilas hit for the first cycle in ABL history on 30 December 2011 against Melbourne. More records were shattered by the Perth Heat, when outfielder James McOwen became the first player to record 100 hits for the ABL and shortstop Mychal Givens set the ABL record for stolen bases in a season (15).

The hot-hitting offense was in no means a reflection of poor pitching. Recording a 1.41 ERA over the season, right-handed pitcher Warwick Saupold of the Perth Heath set the ABL's season ERA record (an effort that led to his first MLB contract with the Detroit Tigers). His teammate, left-handed pitcher Daniel Schmidt, picked up the most wins (6) in the league. Other elite pitchers also emerged from the season with Sydney Blue Sox's left-hander, Dae-Sung Koo leading the league in saves (8) for a combined 20 saves in his ABL career and right-handed pitcher Mike McGuire of the Canberra Cavalry recording the most strikeouts (63) in the league.

James McOwen was the hitting star for the Heat, collecting three hits, including a home run. Game two ran into extra innings with the Melbourne Aces claiming a 3-2 victory over the Heat after 13 innings of play.



## **Perth Heat Champions**

The 'Alcohol Think Again' Perth Heat pulled out the game-three victory over the Jet Couriers Melbourne Aces, repeating as Claxton Shield champions in the 2012 ConocoPhillips ABL Championship Series. For the second straight night, this tightly-contested game went to13 innings; with James McOwen racing home on a wild pitch to score the winning run. Reliever Jack Frawley threw four scoreless innings to finish off the game and earn the win. The series MVP was awarded to Virgil Vasquez for his complete game victory in game one.

# HALL OF FAME INDUCTEES

### **DICK SHIRT**

Richard 'Dick' Shirt is regarded as one of the most colourful figures in Australian Baseball.Since commencing his playing career at a very early age, Dick was involved in State representative baseball as a player and coach for almost three decades

Dick first donned the baggy blues for NSW as a player at the 1958 Schoolboys Competition. He later went on to represent South Australia in the Claxton Shield competition in 1964 and a further nine times between 1966 and 1975. Dick also represented South Australia in the 1966, 1967 and 1968 Chrysler Cup. Following a successful playing career in South Australia, Dick returned to his roots in New South Wales, where he became the Manager of the NSW team for six years between 1976 and 1982. He was also the Assistant Manager in 1975, 1983, 1984, & 1986.

Dick donned the green and gold for Australia 5 times as a player between 1964-1974. He was also the national team coach in 1977, 1979, 1981 and 1983.

Internationally, Dick played for MLB Tampa Tarpons and Wytheville Reds in 1965-66, and the MLB Cincinnati Reds Minor League affiliate in 1967.

Selected to the NSW 75th Anniversary Claxton Shield All Star team; and the Australian 75th Anniversary Claxton Shield All Star team, Dick Shirt is a highly regarded member of the NSW baseball fraternity, a national ambassador for the game of baseball and a welcomed addition to the Baseball Australia Hall of Fame.



#### **GLENN WILLIAMS**

## At just 34 years of age, Glenn Williams is one of the youngest inductees to the Baseball Australia Hall of Fame.

Glenn started playing baseball with the Ingleburn Magpies at the age of six. Shortly thereafter he moved to the Bankstown baseball club, to play under the guidance of Darren Phillips.

A promising young athlete, Glenn has the batboy for the1986 NSW Claxton Shield team; but didn't don the baggy blues as a player for another five years, when he made the Under 16 NSW A Team in 1991. Glenn was a member of the NSW AA Team in 1992; and in the same year represented NSW at the National Schoolboys Competition.

Glenn made his Junior National Team debut in 1992, when he was selected on the Australian AA Team. 1993 was a big year for Williams. He made his Australian Baseball League debut with the Sydney Blues, and at just 16 years of age, Glenn signed a professional contract as a top prospect with the Atlanta Braves. He played with minor league affiliates of the Atlanta Braves, Toronto Blue Jays and Minnesota Twins for the next fifteen years.

Glenn made his Senior National team debut in 1995 against Japan. He won the 1996 ABL Championship with Sydney Blues before transferring to the Sydney Storm where he played until 1999. He was the ABL Golden Glove winner in 1997 & 1998, and named to Sydney's 'Team of the Decade'.

A member of the NSW Patriots from 2003 until 2007 and a key member of the Patriots Claxton Shield team, Glenn continuously hit above .300, and helped the NSW Patriots become Claxton Shield Champions in 2004 & 2005.

In 2005 Glenn made his Major League debut with the Minnesota Twins, and went on to hit in every game in the MLB, posting a 13-game hitting streak and tying a Major League Baseball record. Glenn played with the Twins until 2008.

Throughout his professional career he has been selected into the Minor League AA & AAA All-Star Teams, MVP. Toronto Blue Jays AAA team Syracuse in 2004, Voted best defensive 3rd baseman in International league AAA in the same year, and credited with being one of the most inspirational and motivating players on the 2004 Athens Olympic campaign and recognised with MVP award.

As a national team member, Glenn formed an integral part of many of Australia's key baseball achievements in the past decade. Since making his senior team debut in 1995, Glenn had a thirteen year national team representative career. He donned the green and gold as a member of the 1999 Intercontinental Cup gold medal winning team, the 2000 Sydney Olympic Games, 2001 World Cup, won a silver medal at the 2004 Athens Olympic Games, played against Canada in the 2006 friendship Series before heading to the 2006 World Baseball Classic. He was a member of the 2007 World Cup team, and the 2008 Olympic Qualifier – before retiring as a representative player in 2008.

Following his playing career, Glenn became the Manager of the NSW Patriots in 2009, and led the Sydney Blue Sox to a Playoff berth in the inaugural Australian Baseball League season in 2010/11. He is a part time scout with the Detroit Tigers and is currently the High Performance Manager for Baseball New South Wales, a member of the Junior and Senior National team coaching staff, and a coach at the Major League Baseball Academy program.

Glenn Williams is considered to be one of the 'gentlemen' of our game, a valued and respected member of the Australian baseball fraternity who has reached the pinnacle of our sport at every level. He is a mentor and leader to his peers, and a longstanding ambassador for the game of baseball, making Glenn Williams a welcomed and deserving addition to the Baseball Australia Hall of Fame.



#### SIMONE WEARNE

Simone Wearne's induction into the Baseball Australia Hall of Fame marks the first ever induction of a female athlete into the Hall of Fame. Simone is also the youngest athlete to ever be inducted in to the Hall of Fame.

A highly regarded leader in women's baseball; Simone has paved the way for many young female athletes throughout her career, and continues to be a shining source of inspiration to baseball players around the nation.

Simone Wearne represented the Victorian Women's State Team 10 times between 1999 and 2008; throughout which time she has led her team to 6 National Championship, and was a 5 time winner with 3 complete games.

In 2002, Simone pitched 11 innings for a 1.27 ERA. She was the Championship game pitcher going 4 & 2/3 innings, allowing just 5 Hits, and 1error to secure the win.

In 2004 Simone was the Championship pitcher once again, going 7 innings, allowing just 5 hits, and 1 error for a complete game win In 2005 Simone led her team to the Championship Game for a third time, and pitched 5 innings, allowing 7 hits and 3 errors to secure yet another win.



In 2006 Simone posted a 0.00 ERA for the national tournament, and in 2007 dominated the National women's championships. In her 15 innings of work she posted a 1.40 ERA, and led Victoria to a championship win, pitching 7 innings allowing 9 hits and 3 errors for the complete game win.

In what can only be described as history repeating itself, Simone posted a 1.50 ERA in 2008, taking her team to the Championship once again, where she pitched 7 innings for the complete game win. Simone was a member of every Australian Women's national team between 2001 and 2008, representing Australia a staggering 11 times.

In 2002 she competed in the Women's International Tournament in Geelong, the Women's World Series in 2001 to 2004. In 2006 she was a standout on the IBAF Women's World Cup team, and again in 2008.

She boasts the title as "Winner of most National & International awards" ever in Australian women's baseball.


She won the Women's Baseball World Series Tournament MVP in 2002; and in the same year won the Pitching Award at the Geelong international. She was named a member of the World All-Star team as the starting pitcher at the 2006 Women's Baseball World Cup.

Simone captained Australia in 2008, and won the ABF Female Player of the Year in 2008 & 2009 – making her the only woman to have won the award twice. She was awarded the Women's National Tournament Pitching Award in 2004, 2007 & 2008, she has been the Victorian State Team MVP on 3 occasions, Simone has been the Victorian Division

One Women's State League Pitching Champion twice, and a 6-time Springvale Baseball club Women's Division One Best & Fairest Winner.

In 2010, Simone was named Assistant Coach of Australia's first official junior girls team that competed in the World Children's Baseball Fair in Japan; and is a current and active member of the National Women's Steering Committee.

Simone Wearne is an outstanding athlete, a passionate advocate for our sport, and the most celebrated female player in the history of our game. Simone is a welcomed and deserving addition to the Baseball Australia Hall of Fame.
